4. Proposed New 19 TAC Chapter 117, <u>Texas Essential Knowledge and Skills for Fine Arts</u>, Subchapter D, <u>Elementary</u>, Subchapter E, <u>Middle School</u>, and Subchapter F, <u>High School</u> (First Reading and Filing Authorization)

The board approved for first reading and filing authorization proposed new 19 TAC Chapter 117, <u>Texas Essential Knowledge and Skills for Fine Arts</u>, Subchapter D, <u>Elementary</u>, Subchapter E, <u>Middle School</u>, and Subchapter F, <u>High School</u>, with a recommended implementation date of the 2015-2016 school year. Minor changes were made to the proposal prepared by the TEKS review committees

5. Proposed Revisions to 19 TAC Chapter 101, <u>Assessment</u> (Second Reading and Final Adoption)

The board gave final approval to revisions to 19 TAC Chapter 101, Assessment, Subchapter A, General Provisions, Subchapter B, Development and Administration of Tests, Subchapter C, Security and Confidentiality, Subchapter D, Scoring and Reporting, and Subchapter E, Local Option. The revisions would reflect changes in state law granting rulemaking authority to the commissioner of education.

The board approved for first reading and filing authorization proposed amendments to 19 TAC Chapter 115, Texas Essential Knowledge and Skills for Health Education, Subchapter A, Elementary, §§115.2-115.7, and Subchapter B, Middle School, §115.22 and §115.23. The amendments add bullying prevention to the student expectations in the Texas Essential Knowledge and Skills (TEKS) for Health Education as required by House Bill (HB) 1942, 82nd Texas Legislature, 2011.

10. Per Capita Apportionment Rate for the 2012-2013 School Year (Moved to Consent Agenda)

The board approved revising the per capita apportionment rate for the 2012-13 school year to \$448.148. This is an increase from the rate of \$406.100 set at the November 2012 meeting. The rate changed after the estimate of the amount available for expenditure from the fund changed as a result of the School Land Board transferring an additional \$300 million into the Available School Fund and recognition of a delay in the transfer of Motor Fuels Tax monies into the fund.
