Monica Martinez, interim associate commissioner for standards and programs, explained that the proposed amendments would align the current rule with changes made to the requirements for credit by examination by House Bill 2694 and Senate Bill 1365.

3. Discussion of Proposed New 19 TAC Chapter 74, Curriculum Requirements, Subchapter C, Other Provisions, §74.38, Requirements for Instruction in Cardiopulmonary Resuscitation (CPR)
