The State Board of Education approved the recommendation of the Committee on School Finance/Permanent School Fund that the State Board of Education determine that a distribution of \$1.056 billion for fiscal year 2016 is permitted under Texas Constitution, Article VII, Subsection 5(a)(2).

(4) Decision on Real Estate Investments (Board agenda page III-43) (COMMITTEE ON SCHOOL FINANCE/PERMANENT SCHOOL FUND)

The State Board of Education approved the recommendation of the Committee on School Finance/Permanent School Fund to execute agreement(s) with GreenOak Asia GP II, LP, necessary to make an investment commitment of up to \$50 million in GreenOak Asia (USD) II, LP, a U.S. dollar-denominated fund, subject to continued due diligence and negotiation of fund terms, and also approved the relationship between GreenOak and Hodes Weill Securities, LLC after determining it meets the standards of 19 TAC Chapter 33, Section (9)(j)(5), which has been disclosed in writing, and authorization for contract execution by the Commissioner of Education.

The State Board of Education approved a one-time waiver of the PSF Real Estate Investment Policy Statement and authorized an amount of up to \$50 million, excluding reserves (whether for follow-up investments, expenses, or otherwise) for a potential real estate co-investment with an existing PSF investment manager, as recommended by the Committee on School Finance/Permanent School Fund.

(5) Permanent School Fund Private Equity Program Structure

The State Board of Education approved the recommendation of the Committee on School Finance/Permanent School Fund to select the non-discretionary advisory model as presented by NEPC for phase III of the private equity program.

The State Board of Education approved the recommendation of the Committee on School Finance/Permanent School Fund to contract with Neuberger Berman LLC for (i) a discretionary separate account to invest in private equity co-investments and secondaries; and, (ii) non-discretionary advisory services for primary private equity investments for phase III of the private equity program. Mr. Cortez withdrew his motion without objection from the board.

- 10. Scoring, Results, and Reporting Scoring
 - a) The commissioner of education will determine the process for conducting an equating study. The process may require the Proposer(s) to submit the examination and associated data to an independent organization for the equating study to ensure all proposed examinations are at the same level of rigor. Any costs associated with this study (including reporting of Lexile levels) shall be the responsibility of the Proposer(s). The <u>State Board of Education</u> [commissioner of education] will establish a passing score based on the results of the equating study. <u>The State Board of Education</u> [TEA] will not determine a score that constitutes readiness for post-secondary success.

<u>VOTE</u>: A vote was taken on the motion that the State Board of Education approve the Request for Proposals (RFP) for Texas Certificate of High School Equivalency (TxCHSE) Examination Provider(s), as amended. The motion carried.

Mrs. Bahorich stated that now that the Request for Proposals has been approved, there are certain requirements the board members need to understand.

Christine Hoang, agency contracts and procurement attorney, informed the State Board of Education members that now that the RFP for Texas Certificate of High School Equivalency has been approved, she wanted to advise the members that no communication involving the Texas Certificate of High School Equivalency or the type of service that is the subject of the RFP is permitted with any member until the time the eligible proposer or proposers is or are selected, and referenced it as the black-out period. She stated that if anyone contacts the SBOE to discuss these matters related to the RFP, the members are advised to state that they must comply with state procurement law by not discussing matters related to the RFP, and that any violation of state procurement law could result in a voided procurement.

§33.65. Bond Guarantee Program for School Districts.

- *(b) Definitions. The following definitions apply to the guarantee program for school district bonds.*
 - (10) New money issue—An issuance of bonds for the purposes of constructing, renovating, acquiring, and equipping school buildings; the purchase of property; or the purchase of school buses. An issuance of bonds for the purpose of constructing teacher or student housing is [not] eligible for the guarantee for new money only if it is an integral part of the educational mission of the school district as determined by the commissioner. Eligibility for the guarantee for new money issues is limited to the issuance of bonds authorized under the TEC, §45.003. A new money issue does not include the issuance of bonds to purchase a facility from a public facility corporation created by the school district or to purchase any property that is currently under a lease-purchase contract under the Local Government Code, Chapter 271, Subchapter A. A new money issue does not include an issuance of bonds to refinance any type of maintenance tax-supported debt. Maintenance tax-supported debt includes, but is not limited to:
 - (A) time warrants or loans entered under the TEC, Chapter 45, Subchapter E; or
 - (B) any other type of loan or warrant that is not supported by bond taxes as defined by the TEC, §45.003.

MOTION AND VOTE: It was moved by Mr. Maynard and seconded by Mr. Ratliff, that the State Board of Education postpone until its next meeting proposed amendment to 19 TAC Chapter 33, <u>Statement of Investment Objectives</u>, <u>Policies</u>, <u>and Guidelines of the Texas</u> <u>Permanent School Fund</u>, Subchapter A, <u>State Board of Education Rules</u>, §33.65, <u>Bond Guarantee Program for School Districts</u>, with an effective date of 20 days after filing as adopted with the <u>Texas Register</u>. The motion failed.

MOTION: It was moved by Mr. Ratliff and seconded by Mr. Maynard that the State Board of Education, by an affirmative vote of two-thirds of the members of the board, approve for second reading and final adoption proposed amendment to 19 TAC Chapter 33, <u>Statement of Investment Objectives</u>, Policies, and Guidelines of the Texas Permanent School Fund, Subchapter A, <u>State Board of Education Rules</u>, §33.65, <u>Bond Guarantee Program for School Districts</u>, with an effective date of 20 days after <u>the TEA adopts a revised reserved fund and</u> filing as adopted with the <u>Texas Register</u>.

- (b) Definitions. The following definitions apply to the guarantee program for openenrollment charter school bonds.
 - (17) New money issue—An issuance of revenue bonds under the TEC, Chapter 53, for the purposes of:
 - (A) the acquisition, construction, repair, or renovation of an educational facility of an open-enrollment charter school and equipping real property of an openenrollment charter school, provided that any bonds for student or teacher housing must meet the following criteria:
 - *(i) the proposed housing is contemplated in the charter or charter application; and*
 - (*ii*) the proposed housing is an essential and integral part of the educational program included in the charter contract [not including bonds to be used for the construction of student or teacher housing]; or
 - (B) the refinancing of one or more promissory notes executed by an openenrollment charter school, each in an amount in excess of \$500,000, that evidence one or more loans from a national or regional bank, nonprofit corporation, or foundation that customarily makes loans to charter schools, the proceeds of which loans were used for a purpose described in subparagraph (A) of this paragraph; or

(C) both.
