3. Update on the Accessibility Audit of *Proclamation 2014* Materials (Board agenda page I-29)

Kelly Callaway, instructional materials and educational technology division director, described the content of the report resulting from the accessibility audit of *Proclamation 2014* materials and explained that the audit was conducted to determine the extent to which digital state-adopted instructional materials are accessible to students with disabilities. She added that beginning with *Proclamation 2017*, each publisher will be required to provide an audit report for materials it submits for adoption.

4. Ethics Training

The annual SBOE ethics training was presented by Christopher Maska, the TEA Ethics Advisor.
